

The selection of papers presented at the Conference will be published after a peer-refereeing procedure in the Journal of Thermal Analysis and Calorimetry as a Special Issue / Special Chapter.

The instructions to authors are as follow:

Script requirements:

- Papers should not exceed 10 pages (font: Times New Roman, size: 12, margins: 1 inch, line spacing: 1,5) including tables, figures and references.
- Scripts should be submitted in electronic form. Text is required in MS Word/Rich Text file, figures in a graphic extension (tiff, gif, jpg etc.) and a separate PDF file which contains text, figures and tables simultaneously. May we call the attention of contributors from those countries, writing in different characters than Latin to use only unicode fonts (characters) which fully converting the text and more importantly the symbols as well.
- The recommendation of ICTAC should be followed in nomenclature, abbreviations and symbols.
- The abstract should not exceed 100 words summarising the experiment, results and conclusions followed by 'keywords' in alphabetical order.
- As for the figures, please consider that the Journal's new standard format is two columns. Therefore horizontal width of a single column figure should be maximum 80 mm; stretched in two columns maximum 167 mm. Resolution must be at least 300 dpi and please, note that scanned material is not acceptable. Captions for illustrations should be brief and collected on a separate sheet.
- Coloured pictures can be published in the on-line version of the Journal, but in print we only use black and white figures. Should you request full colour figures in the printed material, this would be a subject of additional payment. Tables each bearing a title, should be self-explanatory and numbered consecutively. The same information should not be given both in tables and figures.
- References should be cited in the text by consecutive numbers and the full reference list at the end of the paper in the following form:

- The author for correspondence will receive the page-proof (PDF file) prior to publication which must sent back with approval/or a list of required corrections as soon as possible.
- The author for correspondence also will receive 25 complimentary reprints by post as the printed version of the issue was published.

During the days of the Conference 24-29 May, 2008 we will collect the manuscripts with the usual acceptance procedure that the Journal has established. For the preparation of papers please, follow the instructions disclosed in the **Journal**.
